<u>Case No. 2014-06-29</u>: Participant is requesting a partial distribution in the amount of \$12,731.33 of her account balance of \$41,019 for loss of wages and medical expenses.

The Hardship Committee approved a partial distribution in the amount of \$12,731.33 based on documentation submitted for loss of wages and medical expenses.

<u>Case No. 2014-06-30</u>: Participant is requesting a partial distribution in the amount of \$12,000 of her account balance of \$68,011.73 for dental expenses and to prevent sale of home.
