<u>Case No. 2015-11-58:</u> Participant is requesting a partial distribution in the amount of \$2,800 of her account balance of \$4,572.05 for medical expenses.

The Hardship Committee approved a partial distribution in the amount of \$2,613.24 based on documentation submitted.

Case No. 2015-11-59: Participant is requesting a partial distribution in the amount of \$3,497.99 of her account balance of \$6,573.04 for mortgage payments that are delinquent.

The Hardship Committee approved a partial distribution in the amount of \$3,497.99 based on documentation submitted.

Bank stated they would not accept partial payments.

<u>Case No. 2015-10-57:</u> Participant is appealing the decision of the HS Committee. Participant is requesting a full distribution of his account balance of \$7,133.76 for loss of wages.

The Hardship Committee did not approve a withdrawal at this time. The committee has requested additional documentation showing the loss of wages. Documentation submitted is insufficient.

<u>Case No. 2015-11-64:</u> Participant is requesting a full distribution of her account balance of \$1,061.36 for eviction.
