<u>Case No. 2013-11-086</u>: Participant is requesting a full withdrawal of his account balance of \$6,917.40 for purchase of a vehicle.

The Hardship Committee did not approve a withdrawal at this time. The committee has requested additional documentation before a decision can be made.

<u>Case No. 2013-11-087</u>: Participant is requesting a full withdrawal of her account balance of \$2,498 for medical bills, loss of wages and to prevent eviction.

The Hardship Committee approved a full withdrawal based on documentation submitted for loss of wages.

<u>Case No. 2013-11-088</u>: Participant is requesting a partial distribution in the amount of \$15,266.31 of his account balance of \$60,219.60 for medical expenses, funeral expenses and mortgage payments that are past due.
