APPLICATIONS APPROVED PRIOR TO HARDSHIP COMMITTEE MEETING

<u>Case No. 2011-05-023</u>: Participant is requesting a full withdrawal of her account balance of \$2,247.25 for reimbursement of medical expenses.

A hardship was approved for a full withdrawal of her account balance based on the EOB's submitted totaling \$3,589.

<u>Case No. 2011-05-034</u>: Participant is requesting a partial withdrawal in the amount of \$4,500 of her account balance of \$5,071.80 for reimbursement of medical expenses.

<u>Case No. 2011-05-025</u>: Participant is requesting a partial withdrawal in the amount of \$7,500 of his account balance of \$10,173.41 for dental expenses.

The Hardship Committee approved a partial withdrawal of participant's balance in the amount of \$6,763 based on documentation showing amount owed for dental expenses.

<u>Case No. 2011-05-026</u>: Participant is requesting a full withdrawal of his account balance of \$4,436.85 for eviction notice and medical expenses.

The Hardship Committee approved a full withdrawal of participant's balance based on documentation provided (eviction notice and explanation of benefits).
