<u>APPLICATIONS APPROVED PRIOR TO HARDSHIP COMMITTEE MEETING</u>

<u>Case No. 2011-06-035</u>: Participant is requesting a full withdrawal of her account balance of \$1,841.18 for medical expenses.

A hardship was approved for a full withdrawal of her account balance based on the EOB's submitted totaling \$2,945.59.

<u>Case No. 2011-06-036</u>: Participant is requesting a full withdrawal of his account balance of \$1,657.61 for medical expenses.

A hardship was approved in the amount of \$958.01 based on the EOB's submitted totaling \$958.01.

<u>Case No. 2011-06-037</u>: Participant is requesting \$3,500 of her account balance of \$5,016.25 for medical expenses.

The Hardship Committee approved a partial distribution in the amount of \$3,500 for medical expenses based on documentation submitted.

<u>Case No. 2011-06-038</u>: Participant is requesting a partial withdrawal in the amount \$12,245.39 of her account balance of \$21,752.75 for mortgage payments (foreclosure), medical expenses and loss of wages.

The Hardship Committee approved a partial distribution in the amount of \$6,783.07 for mortgage payments and medical expenses.

<u>Case No. 2011-06-039</u>: Participant is requesting a full withdrawal of her account balance of \$9,444.17 for mortgage payments that are in foreclosure.

The Hardship Committee approved a full distribution of participant's account pending documentation showing amount owed to bring mortgage out of foreclosure.

<u>Case No. 2011-06-040</u>: Participant is requesting a partial withdrawal in the amount of \$7,648 of her account balance of \$10,466.42 for rent.

The Hardship Committee did not approve a hardship at this time due to the nature and causes not qualifying as an unforeseen emergency.

<u>Case No. 2011-06-041</u>: Participant is requesting a full withdrawal of his account balance of \$1,888.83 for mortgage payments that are in default.

The Hardship Committee approved a full withdrawal of participant's account based on documentation submitted.

<u>Case No. 2011-06-042</u>: Participant is requesting a full withdrawal of her account balance of \$2.208.62 for eviction.

The Hardship Committee approved a full withdrawal of participant's account based on documentation submitted.

<u>Case No. 2011-06-043</u>: Participant is requesting a full withdrawal of her account balance of \$8,921.06 for legal expenses and loss of wages.

The Hardship Committee did not approve a distribution as this time; additional documentation has been requested.

<u>Case No. 2011-06-044</u>: Participant is requesting a full withdrawal of her account balance of \$2,455.93 for funeral expenses.

The Hardship Committee approved a full withdrawal of participant's account for funeral expenses.

<u>Case No. 2011-06-045</u>: Participant is requesting a partial withdrawal in the amount of \$10,000 of his account balance of \$16,110.52 for loss of wages.

The Hardship Committee did not approve a hardship at this time; additional documentation has been requested before a decision can be made.

<u>Case No. 2011-06-046</u>: Participant is requesting a full withdrawal of her account balance \$5,132.36 for legal expenses and loss of wages.

The Hardship Committee approved a full withdrawal of participant's account for legal fees and loss of wages.

<u>Case No. 2011-06-047</u>: Participant is requesting a full withdrawal of his account balance of \$4,285.16 for roof damage.

The Hardship Committee approved a full withdrawal of participant's account pending verification from participant's insurance company as to the amount participant is responsible for.

<u>Case No. 2011-06-048</u>: Participant is requesting a partial withdrawal in the amount of \$10,000 of his account balance of \$56,017.03 for home foreclosure.

The Hardship Committee did not approve a hardship at this time. The committee has requested documentation showing participant's home is in foreclosure and the amount owed to bring current.

Case No. 2011-06-049: Participant is requesting a partial withdrawal in the amount of \$880 of her account balance of \$1,781.77 for storage building.

The Hardship Committee approved a partial withdrawal in the amount of \$878; based on documentation submitted showing funds are for a storage building to store participant's sister's belongings. Participant's sister is unemployed and is unable to live on her own due to being handicapped and going through chemo and radiation treatments.

<u>Case No. 2011-05-027</u>: Participant is requesting a partial distribution in the amount of \$1,455.31 of her account balance of \$2,924.03 for tree damage. The committee previously approved \$500, but participant is requesting the committee to review her case again and to award the additional funds of \$1,455.31 to her.

The Hardship Committee has requested additional documentation from participant's insurance carrier stating the tree damage is not covered under her policy.
