### APPLICATIONS APPROVED PRIOR TO HARDSHIP COMMITTEE MEETING

<u>Case No. 2014-02-11</u>: Participant is requesting a full distribution of her account balance of \$2,465.58 for mortgage payments. In addition to the Notice of Seizure that was previously submitted, participant submitted a statement showing the amount owed to bring the mortgage current is \$4,311.86.

The hardship was approved for a full withdrawal based on the additional documentation submitted.

#### <u>APPLICATIONS REVIEWED</u>

<u>Case No. 2014-02-09</u>: APPEAL: Participant is requesting a partial distribution in the amount of \$24,520.35 of her account balance of \$32,878.41 for loss of wages. The Hardship Committee previously approved for \$2,106; participant appeared before the Committee to appeal the decision made in February, 2014.
