#### **APPLICATIONS REVIEWED**

<u>Case No. 2014-09-53</u>: Participant is requesting a partial distribution in the amount of \$45.000 of her account balance of \$88.710.97 for eviction.

The Hardship Committee did not approve a withdrawal at this time. The committee has requested additional documentation before a decision can be made.

<u>Case No. 2014-09-54</u> Participant is requesting a partial distribution in the amount of \$5,725.57 of her account balance of \$6,327.52 for medical expenses.

The Hardship Committee approved a partial distribution in the amount of \$5,725.57 based on documentation submitted.

<u>Case No. 2014-09-55</u>: Participant is requesting a partial distribution in the amount of \$5,670 of her account balance of \$7,161 for medical expenses.

The Hardship Committee approved a partial distribution in the amount of \$5,670 based on documentation submitted.
