B. City Council Meeting for August 6 2020:

- 1. Cal No. 33021: creating regulations pertaining to City's use of surveillance technology (deferral requested to 8/20/20) Theodore Thompson, Renard Bridgewater, Marvin Arnold, and Allie Huddleston all spoke on the effects on black and brown people if this ordinance passes. More research is needed. There are question about the intent of this ordinance. Deferral has been requested until the 8-20-20 City Council meeting.
- 2. Cal No. 33025(ZD 36/20): Conditional Use request to permit a residential care facility at 6400-6464 Hayne Blvd.: The intention is for a residential home for Veterans
- 3. Cal No. 33056(ZD 10/20): Conditional Use Request to permit and educational facility (primary & secondary) at 8820-8900 Hayne & 7928 Burke Ave.: Comm. Legaux (Villa Sites subdivision) voiced objections of the project
- 4. Cal No. 33057(ZD 37/20): Zone change request from SB-1 & S-RS to S-MU at 13860-13880 and 13900-13990 Hayne Blvd.: There were no objections noted.
- 5. Motion M-20-237: to consider zone change from C-1 to C-3 at 14201 Michoud Blvd.: Comm. Blouin (Village de l'Est) is checking on this property which is actually located in Oak Island.
- Motion M-20-242: to establish a new IZD to be named Lower Ninth Ward Off-Street Parking IZD. (MOTION WAS RESCINDED by CPC Hearing Notice received on 8/6/2020)

A. BZA 052-20: Request for waivers to permit a retail goods store with excessive front yard setback, insufficient rear yard setback and parking as the dominant visual
