I. Call to order/Roll Call

- **IV. Treasurer's report:** The report covering thru October 31, 2020 was read by Comm. Karol Sanders.

V. New Business

- A. NOE Economic Development Administration: Advisory Committee Meeting This group, the Advisory Committee, is a federally funded research initiative focused on evaluating opportunities for resilient economic development in NOE. It will describe a resilience-based strategy for economic-development in NOE as well as illuminate resilience considerations for other communities in Orleans Parish interested in leveraging their designated Qualified Opportunity Zones (QOZ) as catalysts for much needed economic development.
- **B.** Ride New Orleans: New Link. Mr. Sam Buckley, Regional Planning Commission, made a presentation along with Mr. Vivek Shah, RTA Director of Planning on proposed changes to the transit system as a part of the 'New Links' project and get feedback from group and share resources on proposed changes. They presented a survey link to send out for feedback. Comm. Troy Henry asked what will these changes, with influx of working poor into NOE, do tour property values. Mr. Buckley said that the changes are for people where they are now and who currently use the system, to make it more functional.
- **C.** Outreach to former CAB members we are in the process of composing a letter to send out offering their come back to ENONAC or to offer another name/person to participate with ENONAC
- D. Virtual Holiday Party: ideas Pres. Scineaux-Richard explained how this idea came about. Anyone who may have any ideas of how to accomplish this, could be on a committee. She asked Comm. Jourdain if he could help. There was discussion on price, DJs, and will it be well-attended enough to generate funds. Comm. Jourdain said he is willing to be on the committee. Comm. - A. Cal. No. 33,148: ZD 55/20 creating an exception allowing continued use of non-conforming pole signs City Council approved this on November 5. Pres. Scineaux-Richard said that quite a few poles and signs have fallen down during hurricane Zeta; just what they were afraid of.
- B. Impact Grant project completion Comm. Legaux reported that all funds were used and reported to the City and the check (\$750) is/was picked up by Comm. Sanders. Job well done by group. Water barrel was brought to the office for watering of plants. Task was completed. Pres. Scineaux-Richard commended those who she saw working on Saturday on Bullard; Comms. Woods, Williams, Legaux and her husband. Comm. Legaux said that in speaking with Sylvain-Lear, Dept. of Sanitation, she said that 2 trash cans can be installed on Downman, Crowder, Read and Bullard for walkers to help keep areas clean. We just need to identify those places.
