# Discussion of Future Health Care Workforce Needs

Vice Chair Bailes introduced Dr. Kim Hunter Reed, Commissioner of Higher Education, and invited her to join the Council's round table discussion on the supply and demand of nurses as well as the future healthcare work force needs in the state. Dr. Reed began by sharing an article featuring portraits of New Orleans' healthcare workers reflecting how they felt during the past year during the COVID pandemic. She also expressed her gratitude for all healthcare workers and how this year was truly the "year of the nurse." Vice Chair Bailes opened the floor to discussion regarding the recommendations put forth by the Council in the 2020 annual report. Recommendations included: addressing the shortage of faculty, number of students not admitted into nursing programs, the lack of funding for nursing education, and the challenges related to increasing the diversity in Louisiana's nursing workforce. The Council discussed the need for more competitive salaries for nursing faculty. Discussion continued that more competitive salaries would result in the recruitment and retainment of nursing educators. Also, the issue of out of state schools participating in clinical components in the Louisiana was also brought up. The discussion also highlighted the need for supports to promote student success once they are admitted into the nursing program. All agreed that though there are student support services in place, many students are hesitant to ask for assistance or utilize these services until it is too late. A solution was suggested around emphasizing the expectation of nursing students while in their education programs. Dr. Reed asked the Council to speak on the recommendation of reinstating the stipend program that was once administered by the BoR. Many Council members attested that this stipend program was every successful and that it helped immensely with securing faculty at the institutions because of the monetary incentive. Dr. Reed asked if any Council members were familiar with the model where public institutions partnered with hospitals to assist in the paying of clinical faculty. There was discussion of similar partnerships amongst the community colleges and local area hospitals, but it is not observed statewide. Dr. Reed asked Mr. Paul Salles, past chair of the HealthWorks Commission and President of the LA Hospital Association, to assist in gathering more info on these partnerships. One of the last topics discussed pertained to retired nurse faculty returning to the classroom. Dr. Reed made note to track this recommendation since it would involve a change in legislation. In closing, Dr. Reed thanked the Council for all their hard work and assured them that she and the BoR will serve as advocates of this work.

No public comments were made during the meeting.

### **Next Meeting Date**

Vice Chair Bailes stated that next month towards of the end of April, the NSDC will have a short meeting to discuss future subcommittee work. After this meeting the entire Council will begin a quarterly meeting schedule with meetings held on July 21 and October 28, 2021, both starting at 1pm. Ms. Landry will send out correspondence closer to the meeting dates.
