Ms. Calmes presented a report on Licensure and Practice. The department continues to prioritize timely and efficient licensing to contribute to their workforce.

Currently, they have renewed 17,473 licensees from a total of 42,357 due to renew this season.

Recently, they have also approved a new CES (Credentials Evaluation Service) provider Spantran. They exceeded or met all NCSBN's (National Council State Boards of Nursing) criteria for providing a service to help assist with removing all the barriers to licensure credentialling.

This past year, they have collectively provided 9 presentations to schools and organizations.

Dr. Calmes attended the mid-year and annual meetings of NCSBN.

Staff attended the APRN roundtable virtually.

They are looking forward to the new year and have already begun discussing ideas for process changes as they strive to be as efficient as possible.

Dr. Tomekia Luckett, Dean School of Nursing, Louisiana Christian University, was present to provide information and to answer questions from the Board.

Motion: by W. Palermo, seconded, that the Board approve an extension of Louisiana Christian University's teach out program for the students remaining in the old BSN program.

Agenda Item 2.1.2.6 80% NCLEX-RN First Time Pass Rate

Summary/Background presented by Dr. Lyon.

Dr. Lyon reported she is proposing a revision to LAC 46.XLVII.3535.B that will address the concerns of the Board and thoughts that were shared by different faculty.

The rule currently reads:

"The undergraduate nursing education degree program shall have a pass rate of 80 percent or greater achieved by the candidates taking the licensure examination for the first time in any one January to December calendar year, or the program shall be placed on probation."

Dr. Lyon is proposing and asking the Board to approve to strike the language "or the program will be placed on probation," and then adding 1 and 2 as follows:

Number 1, "That an undergraduate nursing education degree program that does not meet the 80% first time pass rate in any January to December calendar year will receive a letter of warning from the LSBN Board."

Number 2, "After two consecutive years of not meeting the 80% NCLEX-RN first-time pass rate standard or two years out of the last 3 years of not meeting the 80% NCLEX-RN first time pass rate standard, the undergraduate nursing education degree program will be placed on probation (See §3509.C.1 and 2)."

This will give everyone two years to receive just a letter of concern if they do not reach the 80% first time pass rate. And after that second year, or any two of the last three years of not meeting the standard, they would be put on probation.

Discussion ensued regarding the proposed revision.

Motion: by F. Pinkney, seconded, that the Board approve revision of LAC 46.XLVII.3535.B to allow for letters of concern to be issued to schools that don't achieve the 80% NCLEX-RN first time pass rate before being placed on probation.

There being no nays or abstentions, the motion carried.

Dr. Lyon stated she will begin the rule making process.

Agenda Item 2.2 Compliance Division

Agenda Item 2.2.1 Chief Compliance Officer

Ms. Papillion gave a report on Priority 1 cases.

At the start of December 2023, the Compliance Department had 25 open Priority 1 cases.

Ms. McNabb requested clarification of a Priority 1 case. Ms. Papillion stated that that is their highest priority category of cases posing high risk of substantial harm to the public or patients.

Five Priority 1 cases were out of compliance, which gives a 20% out-of-compliance rate.

Discussion ensued regarding how Priority 1 cases are worked.

Ms. Papillion thanked her team leaders and compliance investigators and officers who recruit and train new staff members and who also retain the valuable staff they have.

Dr. Lyon reported that there are challenges that staff have in getting all the needed information to act against a license, particularly if the license is going to be summarily suspended.

Ms. Papillion was available for questions.

Agenda Item 2.2.2 RNP/Monitoring

A report was presented by Ms. Beckwith on the activities of the RNP/Monitoring Department.

Staff continues to increase awareness of RNP Monitoring. Year to date, they have provided 19 RNP presentations.

On September 18, Uprising Addiction Treatment Center, Shreveport, Louisiana came to LSBN and presented to the staff. An application was submitted to become Board recognized and was denied as they did not meet the criteria.

On September 20, Ms. Butler, RNP Program Manager, did an RNP presentation at Our Lady of the Lake School of Nursing.

On September 26, Ms. Papillion and Ms. Beckwith traveled to UF Health, Gainesville, Florida. UF Health is currently a Board recognized treatment center and requested to provide additional services. On September 27, a site visit was conducted there, and UF Health was approved to provide IOP, outpatient evaluations, and PHP.

On October 16, a virtual RNP presentation was made at Northwestern State University in Shreveport.

On October 25 and 26, Ms. Beckwith virtually attended the Louisiana Action Coalition 2023 Culture of Health Summit.

On November 13, Ms. Papillion, Ms. Rice, and Ms. Beckwith had a meeting at LSBN with Casey Loper, Program Manager, Mississippi Nurse Voluntary Program, to discuss LSBN monitoring and RNP processes to help grow their program.

Ms. K. Pohlman, RNP Program Manager, has retired after 13 years of service. Ms. Papillion and Ms. Beckwith have started interviewing for a new RNP Program Manager.

As of November 30, RNP Monitoring had a total of 437 participants: RNP was a total of 260 and Monitoring was 177. Of the 260 RNP, there were 124 confidential and 136 disciplinary.

Ms. Beckwith was available for questions.

Agenda Item 2.2.3 Compliance

A report of the activity of the Compliance Department was presented by Ms. Carter.

They have made visits to various facilities throughout Louisiana: These visits enhance LSBN's visibility and continue to build rapport with key stakeholders in the community.

Their goal is to educate the public as much as possible about investigations, activities, and LSBN's processes.

They have taken advantage of many training opportunities for professional development to continue to gain knowledge to serve and protect the citizens of Louisiana.

Ms. Beckwith, Dr. Calmes and Ms. Carter received a fellow award for completion of the mentorship program for LAC Nurse Leadership Institute on September 16, 2023.

They currently have sixty-one 2021 cases, one hundred 2022 cases, and two hundred ninety-four 2023 cases.

Ms. Carter thanked her department for all the challenging work they have done this past year.

Ms. Carter was available for questions.
