VIII. Financial Report

Dominique Flugence provided the Financial Report. As of September 30, 2017 the total assets were \$11,373.49 with no major expenses or changes to date.

IX. Chairman's Report

Chairman Gene D'Amour provided brief updates three topics. The first is a goal of getting a National Cancer Institute Cancer Center for the Louisiana Cancer Research Consortium. The second was an update that the Urban Land Institute would be in New Orleans in November examining Charity Hospital and hopefully will include the larger Biodistrict footprint as part of their analysis. The third was the following motion:

"Motion to proceed to collaborate with Latter & Blum and any other natural partners and stakeholders in conducting a seminar during the week of January 29 – February 2, 2018, for the purposes of enhancing public awareness regarding the BioMedical District."

This motion was moved by Rebecca Conwell and seconded by Harold Gaspard. A vote was taken and the motion passed.

X. Infrastructure Development Presentation – Pres Kabacoff

Pres Kabacoff gave a thorough and visionary presentation on the opportunity for transit oriented development and place-making near research hubs that incorporated Charity Hospital into a very broad plan. The presentation was titled "New Orleans, LA: Center City Catalytic Transformation." A slide summarized the plan to repair crumbling infrastructure, repair three 'blighted' center city neighborhoods, create 10,000 new jobs, and build 700 mixed-income housing units alongside job training and disadvantaged business participation.

The plan included the expansion of Duncan Plaza in the space of the old VA's building, a pedestrian park stretch, RTA transfer Station, 'blue way' canal systems, a 'New Orleans Cultural Trail,' and more. Other components included the need for a state fund to recruit and hire leading scientific and healthcare specialists.

Kurt Weigle of the Downtown Development District also gave a presentation about the correlation between research spending and high quality care. He encouraged the collaborative efforts between our public and private universities in order to spur research funding like our

peer cities and also spoke to the power of hiring leading Principal Investigators. His goal is to target \$120 million of NIH funding by 2023, focused on no more than three specialty areas.

A very brief update was given about the New Orleans Health Innovators Challenge.
