Presentation YouthForce NOLA

Dr. Henderson introduced Ms. Cate Swinburn, Co-Founder & President of YouthForce NOLA, and her team, Mr. Rahmel Fuller, Program Manager; Mr. Nathan Stockman, Director of Learning Design; and Ms. Paris Woods, Chief of Programs. Ms. Swinburn described the purpose, strategies, and impact of the organization, which is "an education, business, and civic collaborative that increases economic equity by preparing New Orleans public school students for successful pursuit of employment in industries with good wages and growth opportunities."

The importance of soft skills was emphasized. Ms. Swinburn also showcased a few success stories of young people who had taken advantage of the opportunities provided by the organization.

Four recommendations that were given to the Commission were to (1) be visionary; (2) be specific and transparent; (3) define benchmarks; and (4) be nationally and internationally competitive.

Finalization of Definition of College and Career Readiness

Dr. Henderson led a lengthy and rigorous discussion about the proposed definition of college and career readiness. Even after several suggestions to amend the draft, a final definition was not decided, and it was agreed to continue to work on a comprehensive definition to share with the Board of Elementary and Secondary Education (BESE) in the very near future.

In addition, Dr. Tristan Denley, Board of Regents Deputy Commissioner of Academic Affairs and Innovation, discussed the Academic Affairs Policy 2.18 Gateway Mathematics and English Course Placement Requirements and corequisites.
