JUVENILE JUSTICE REFORM ACT IMPLEMENTATION COMMISSION

Meeting Minutes

December 1, 2023

The Juvenile Justice Reform Act Implementation Commission met in a regular session on Friday, December 1, 2023, in the Governor's Pressroom on the 4th Floor of the Louisiana State Capitol. The meeting was called to order by Chairperson, Senator Royce Duplessis, and a roll call by Shalela Dowdy was taken as follows:

 - There are currently 3083 youth in custody of OJJ with seventy-four percent of that number under community supervision. School performance scores have increased overall. OJJ identifies the following needs: (1) more clinicians to address increasing mental health concerns, (2) increase in funding for communitybased providers, and (3) solutions to combat transportation barrier to family engagement.
- American Institutes for Research report was given by Consultant, Simon Gonsoulin.
 - Provided an update from the retreat that occurred earlier on data points that should be looked at in reference to early prevention and prevention efforts to youth incarceration.
- JJRAIC report given by Southern University Law Center Director of Louis A. Berry Institute for Civil Rights & Justice, Ada Goodly Lampkin.

- Provided an update on JJRAIC's mission and vision. The new by-laws were introduced to the commission for their review and approval.
