BUDGET REPORT

Mr. Ty Carlos reported that as of May 31, 2020 the LCDA had earned 75% of the budgeted revenues, while incurring 95% of budgeted expenditures. A motion to accept the May 31, 2020 budget report was made by Mr. David Rabalais, seconded by Mr. Mack Dellafosse and with no opposition the motion carried.

TECHNICAL AMENDMENT

Cypress Black Bayou Recreation and Water Conservation District Project Series 2015

Mr. David Rabalais explained the Development Committee was presented with a Technical Amendment request regarding the Cypress Black Bayou Recreation and Water Conservation District Project, Series 2015. Mr. Rabalais explained the Technical approval was requesting a deferment of the District's July 1, 2020 Principal payment. Mr. Rabalais explained Citizen's Bank had agreed to defer the July 1, 2020 Principal Payment and the Principal payment would be paid back at any time on or before the final maturity date without penalty. A motion for technical approval to defer the July 1, 2020 Principal payment was made by Mr. David Rabalais seconded by Mr. Mack Dellafosse and without objection the motion carried.

Mr. Carlos explained to the Executive Committee the Authority received a clean opinion, no audit findings, no material weaknesses, deficiencies, or material of non-compliance. Mr. Carlos provided the Executive Committee with the Financial Highlights explaining the Authority ending 2019 with a Clean Audit and overall increase in net position. A motion to accept the Audit Report for the year ending December 31, 2019 was made by Mr. David Rabalais, seconded by Mr. Guy Cormier and without objection the motion carried.

EXECUTIVE DIRECTOR'S REPORT
