Chairman Mayor David Camardelle asked for any questions or corrections. With no comments or corrections brought to the Committee, motion to accept the minutes of the LCDA Executive Committee meeting of September 12, 2019 was made by Mr. David Rabalais, seconded by Mayor David Butler and without any objection the motion carried.

BUDGET REPORT:

Mr. Ty Carlos reported that as of September 30, 2019 the LCDA had earned 131% of the budgeted revenues, while incurring 89% of budgeted expenditures. A motion to accept the budget report was made by Mr. David Rabalais, seconded by Mayor David Butler, and with no opposition the motion carried.

TECHNICAL AMENDMENTS

City of Lake Charles Public Improvement Project, Series 2019

A motion to accept the recommendation was made by Mr. David Rabalais, seconded by Mayor Billy D'Aquilla and without objection the motion carried.

FINAL APPROVAL

Livingston Parish Courthouse Project, Series 2019 (waiver request)

Mayor David Butler made a motion to approve the requested waiver of the rules to obtain the Authority's final approval before approval of State Bond Commission, seconded by Ms. Mary Adams and without objection the motion carried.

Livingston Parish Courthouse Project, Series 2019

Ms. Carmen Lavergne of Butler Snow Law Firm presented the request for the Livingston Parish Courthouse Project, Series 2019. Ms. Lavergne explained the request was a refunding of the Livingston Courthouse Series 2011, NTE \$17 million and the refinance would be a taxable refunding. Mayor David Butler asked how much it would save the parish, Ms. Lavergne explained the interest rate would change from 4.61% to 3.3% saving an estimated \$1.3 million, the repayment of the Bond would come from filing and recordation fees. A motion contingent on State Bond Commission approval was made by Mr. David Rabalais, seconded by Ms. Mary Adams and without objection the motion carried.

OTHER BUSINESS

EXECUTIVE DIRECTOR'S REPORT

Mr. Ty Carlos gave a report to the Executive Committee, which covered several topics of interest. Mr. Carlos provided in each member folders the investment management account statements for both Hancock Whitney and LAMP as well as the monthly credit card statement. Mr. Carlos reported in September he attended a ribbon cutting ceremony for the Student Housing Complex at Southeastern University. Mr. Carlos and Mr. Toby Cortez of Stifel provided the committee with brief details of the new water system implemented by the University, explaining the great savings to the University. A motion to approve the Director's report was made by Mr. David Rabalais, seconded by Ms. Mary Adams, and with no opposition the motion carried.
