## **MINUTES**

Minutes of the LCDA Executive Committee meeting of July 11, 2019 were emailed to all members prior to today's meeting and copies were also provided in the Committee meeting folders. Mayor David Camardelle asked for any questions or corrections. With no comments or corrections brought to the Committee, motion to accept the minutes of the LCDA Executive Committee meeting of July 11, 2019 was made by Mr. David Rabalais, seconded by Mayor Billy D'Aquilla and without objection the motion carried.

### BUDGET REPORT

Mr. Ty Carlos reported that as of July 31, 2019 the LCDA had earned 153% of the budgeted revenues, while incurring 90% of budgeted expenditures. A motion to accept the budget report was made by Mayor David Butler, seconded by Mr. David Rabalais, and with no opposition the motion carried.

## DEVELOPMENT COMMITTEE REPORT

Mr. Ty Carlos explained the Development Committee was presented with a preliminary request for the Glen Retirement System from Ms. Carmen Lavergne and Ms. Debra Williams CEO of the Glen Retirement System. Mr. Carlos explained the project was NTE \$52 million for the purpose of financing and refinancing a portion of the cost of acquiring, constructing and equipping certain facilities of the retirement system, funding a debt service reserve fund and paying a portion of the costs of issuance. Mr. Carlos continue by explaining the repayment of the bond would come from revenues of the system. Mr. Carlos concluded by stating to the committee a waiver request and the project were both recommended by the Development Committee. A motion to accept the waiver of the minimum denomination requirement was made by Mayor Billy D'Aquilla, seconded by Mr. Guy Cormier. A motion to approve the project request was made by Mayor Billy D'Aquilla, seconded by Mr. Guy Cormier, and with no opposition the motion carried.
