MINUTES:

BUDGET REPORT:

TECHNICAL AMENDMENT:

Chairwoman Adams explained the Development Committee was presented with a Technical amendment request for the Calcasieu Parish School Recovery Revenue Bonds, Series 2020. Ms. Adams explained the technical request would change the Trustee to Regions Bank and employ Dunlap Fiore Law Firm as Issuer Counsel. Mr. Mack Dellafosse recused himself and abstained from voting. A motion to accept the technical amendment request was made by Mr. David Rabalais, seconded by Mr. Guy Cormier and with no opposition the motion carried.
