MINUTES:

Minutes of the LCDA Executive Committee meeting of October 12, 2023, were emailed to all members prior to today's meeting and copies were also provided in the Committee meeting folders. Ms. Mary Adams asked for any questions or corrections. With no comments or corrections brought to the Committee, a motion to accept the minutes of the LCDA Executive Committee meeting of October 12, 2023, was made by Mr. Mack Dellafosse, seconded by Mr. Jim Holland and with no opposition the motion carried.

BUDGET REPORT:

Mr. Ty Carlos reported that as of October 31, 2023, the LCDA had earned 130% of the budgeted revenues, while incurring 93% of budgeted expenditures. A motion to accept the October 31, 2023, budget report was made by Mr. Jim Holland, seconded by Mr. Mack Dellafosse with no opposition the motion carried.

DEVELOPMENT COMMITTEE REPORT: NA

TECHNICAL AMENDMENT:

Nicholls State University Student Housing / NSU Facilities Corporation Project

Mr. Mack Dellafosse presented the technical amendment request to the Executive Committee. Mr. Dellafosse explained the technical amendment was requesting approval for a resolution previously adopted on March 14, 2019, April 14, 2022 and June 9, 2022 for a NTE \$42,500,000 to refund all or a portion of the 2007B bonds, funding a deposit to a debt service reserve fund or paying the premium for a debt service reserve fund surety policy, paying any applicable termination payment required to terminate an interest rate swap and paying costs of issuance of the bonds, including a premium for a bond insurance policy if necessary. Mr. Dellafosse explained the request authorizes an increase in the not to exceed interest rate as set forth in the Prior Resolutions to 7.50%. A motion to accept the technical amendment request was made by Mr. Mack Dellafosse, seconded by Mayor David Butler and without an objection the motion carried.
