## **Call to Order**

Dr. Powell called the meeting to order at 12:30 p.m.

## Motion to Amend the Agenda

Lee Felterman made a motion to amend the agenda as follows: Move Collections Committee report to the second item of business, move the Irby Committee report to the third item of business, and add a new item: an election for officers, per nominations made by Dr. Powell. The motion was **unanimously approved**. Those nominations are: Anne Redd as Vice Chairman, Melissa Steiner as Secretary, and Will Wilton as Irby Committee Chairman.

## **Collections Committee Report**

Melissa Steiner made a motion to accept the loan from the Armstrong Museum for collages from the Louis Armstrong collection. Carolyn Morris seconded the motion, which was then **unanimously approved.** Fairleigh Jackson distributed the deaccession policy to all board members, which meets the standards of the AAM.

## **Irby Committee Report**

Rennie Buras presented the proposed 2017-18 Irby Budget. Will Wilton moved to adopt the Irby Budget (Exhibit A). The motion was seconded by Lee Felterman. There was a call for public comment, but no requests to speak were received. The motion was **unanimously approved**.

Major Repairs projects were discussed by Rennie Buras (Exhibit B). Tuck pointing at the Pontalba will begin with Irby funds approved in this year's budget. Approval was received from Facility Planning and Control for major repair work at Madame John's Legacy. \$345,000 from the Irby fund balance, in addition to the budget approved, is being requested of the board, to supplement this project. Will Wilton moved to appropriate the funds as requested. Larry Schmidt seconded the motion. There was a call for public comment, but no requests to speak were received. The motion was **unanimously approved**.

Announcement was made regarding the December 11<sup>th</sup> meeting in Natchitoches. Irby will meet at 8:30 a.m. followed by the full board meeting.

#### **Lieutenant Governor**

The Lieutenant Governor thanked the group for their service. He discussed meetings with the Natchitoches Foundation Board and plans for the Tercentennial.
