NOPD Report:

Jim Olsen reported on the crime statistics and trends for February. There were 34 crimes reported this year compared to 31 in February of last year. There were 1,324 calls for service, 27 traffic warnings, 160 residential checks, 650 business checks and six pedestrian check this February. One felony and five misdemeanor arrests were made by MCSD officers.

Financial Report:

Jim Olsen reported that there was approximately \$302,000 cash on hand at the end of February. We received a check for approximately \$24,000 in early March.

Website:

Tung Ly is out of town and unable to deliver a report on the status of the MCSD website. The MCSD Board has regained control of the website.

Status of Vehicles:

Jim Olsen gave a report updating the new vehicle's preparation, Unit B16088. It is awaiting installation of the computer. Unit B1304 will soon be retired from the fleet. Two other units are over 100K miles but should remain in service for the foreseeable future.

Discussion of Modified App: Because of the Crimestoppers Banquet, the planned speakers could not attend this meeting. A special meeting will be scheduled for that presentation.

Discussion of Parcel Fee adjustments 2019 Statute renewal: MCSD Board received a legal opinion from counsel. Amendments to the statute will be on the April agenda.

New Crime Cameras:

We have 5 new cameras in the First District portion of the MCSD. The installation of those cameras in the Third District is ongoing.

Public Comments:

Darby Shields reported that 53 crime cameras are being installed on the Lafitte Greenway.
