BOARD MEETING

6/22/2021

A meeting of the Board of Commissioners (the "Board") of the New Orleans City Park Improvement Association (the "NOCPIA") was called to order Tuesday, June 22, 2021, at 4 p.m. by Jay Batt. The meeting was held in-person and via Zoom at the Pavilion of Two Sisters.

President Jay Batt called the meeting to order. The Pledge of Allegiance was recited by the Board.

A quorum is present and voting throughout the meeting.

A motion was made to accept the minutes from the May 25, 2021 meeting, as circulated via email. The motion was seconded, voted on, and approved unanimously.

PUBLIC COMMENTS: There were no public comments

Resolution 2021-07 was unanimously approved authorizing PEPCO to procure a restaurant facility at City Putt and Tricentennial Mall through a Request for Proposal.

Chief Financial Officer, Keith Hemel presented, and reviewed management's recommendations for the 2021-2022 operating budget. Hemel noted that the Executive, and Finance & Audit Committee reviewed management's budget recommendation; and unanimously recommended the budget for approval by the Board. He noted that the projected revenue increased from \$17.5 million to \$21.3 million mainly due to the City Millage Hemel reviewed the Key Factors and Key Assumptions for this year's budget. After discussion, the Board unanimously adopted the 2021-2022 budget. President Batt thanked Keith Hemel for his excellent work on the budget.

P, A&E/Wisner Tract – Commissioner Bill LeCorgne updated the Board on various projects.
