## Consideration of Minutes from October 12, 2011 Meeting

## **Review of Program Operation**

Joe Fontenot, PMP Manger, presented the following statistical information and provided printouts on all information:

Ms. Thania Elliot (LSBME) stated that, based on practitioner feedback, she believes practitioners would utilize PMP information more if delegate accounts were allowed. Delegate accounts would free the practitioner from querying a patient profile by allowing others to have individual access. Mr. Joe Fontenot, PMP Manager (LABP) advised that if access were allowed for non-credentialed persons there would be no license to reprimand for illegal access and/or disclosure of PMP information. Pete Tufaro (Sheriff's Association) stated that delegate accounts may enable a doctor to use his appointee when attempting to avoid legal ramifications.

Ms. Thania Elliot (LSBME) moved for a motion that consideration of delegate accounts be added to the agenda for the next PMP Advisory Council Meeting. This motion was seconded by Greg Waddell (LSMS). Motion carried with no opposition.

Mr. Joe Fontenot, PMP Manager (LABP) made note that Carisoprodol appeared on the top ten lists for 2010 and 2011 after becoming a schedule IV on August 15, 2009. Tramadol also appeared on the top ten list for 2011 after being identified as a drug of concern on September 1, 2010.

Ms, Thania Elliot (LSBME) questioned when information regarding drugs of concern would be reviewed to determine if the said drugs should be classified as a controlled dangerous substance. After Council discussion it was decided that information on the utilization of tramadol will be presented at the October 2012 Advisory Council Meeting.

After reviewing the legislation, Mr. Randal Johnson (LIPA) moved that the PMP Advisory Council support the legislation as drafted with amendments. This motion was seconded by Mary Staples (NACDS). Motion carried with no opposition.
