Interstate Sharing

Joe Fontenot updated the Advisory Council on the following information:

Mr. Fontenot will be meeting with the state of Arkansas next week and the state of Mississippi later in the year to discuss sharing. He also informed the Advisory Council that he anticipates data sharing with these states by the end of the calendar year.

Status of Public Bidding Process

Mr. Aron reminded the Advisory Council that the Louisiana Board of Pharmacy is currently in the bidding process for a software vendor for the Prescription Monitoring Program. The PMP's current contract with HID is set to end on November 30, 2013. The Louisiana Board of Pharmacy is currently reviewing bids and anticipates that the PMP may or may not have a new vendor by December.

Delegates of Prescribers and Dispensers

Mr. Blackwell requested information on the status of delegate accounts. Mr. Fontenot informed the Advisory Council that the Regulation Revision Committee would be meeting later this month to discuss rulemaking for delegates. Mr. Aron floated the concept of having 3 to unlimited delegates based on the practitioner's professional judgment. Also up for discussion is whether or not to require all delegates accessing the program to be credentialed healthcare parties.

<u>Calendar Notes</u> 2014 tentative meet dates are: January 8, April 9, July 9, and October 8, 2014.
