Delegates

Mr. Fontenot informed the Advisory Council that our vendor, O-Tech, implemented web access for delegates on September 22, 2014. He informed the Advisory Council of the account set-up process and use of the program by delegates.

Delegate Registration Procedures:

- Delegate completes an online registration which includes adding the DEA number of the authorized prescriber or the license number of the authorized PST for whom they will be a delegate
- An email is sent to the authorized prescriber or PST ("master account holder") which prompts them to approve the delegate through their established access.
- Once approved the delegate is then linked to that "master account holder" and may begin querying patient information on their behalf through their own established account.

An authorized prescriber or PST may have an unlimited amount of delegates and a delegate may have an unlimited amount of prescribers or PST for whom they are the delegate. The master account holder has the ability to not only enable the delegate's access but also disable the delegate's access. They also have the ability to review the delegate's activity in the PMP database from their own account.

Louisiana Health Care Quality Forum – LaHIE (Louisiana Health Information Exchange)

Mr. Fontenot informed the Advisory Council that the Louisiana PMP has been working with the Louisiana Health Care Quality Forum, which is the administrator of the Louisiana Health Information Exchange (LaHIE), to establish a connection with the LA PMP. The Louisiana PMP anticipates completion of the connection in the first or second quarter of 2015.

Review of New Federal Rules & State Laws re Controlled Substances

Mr. Fontenot updated the Advisory Council on recent legislation in regards to Carisoprodol and Tramadol products.
