PMP Interconnect

 Mr. Fontenot informed the council that within the last 30 days, the number of requests into the Louisiana PMP from Arkansas and Mississippi, using the PMP Interconnect, has totaled 34,284. The number of requests into Arkansas and Mississippi from Louisiana PMP users totaled 38,613. This quarter, Louisiana PMP users queried the Arkansas PMP 30,165 times and the Mississippi PMP 40,067 times.

Gateway

Mr. Fontenot discussed the Gateway with the Advisory Council. Currently, Kroeger has begun using the Gateway to query their patients. Mr. Fontenot is currently working on turning on the Chitimacha Indian Tribe once their users have all registered with the Louisiana PMP.

Record Retention

The topic of Record Retention was raised. The advisory council members recommended that the PMP have 5 years of data readily available and that all other data be archived.
