# Consideration of Minutes from July 9, 2008 Meeting

Minutes were approved by consensus of the Council.

#### **Introduction of Program Staff**

Joe Fontenot is the Program Manager. Sarah Blakey is the Assistant to the Program Manager.

#### **Review of Implementation**

Mr. Fontenot reviewed some keys issues that have arisen.

Several inquiries have been made regarding the identification number requirement for reporting to the Program. The regulations require either a state issued ID number, driver's license number, or social security number. However, Mr. Fontenot pointed out the identifier number is not considered primary source information for the Program's purposes but is instead a secondary source for cross referencing purposes. With regard to an animal's prescription, Mr. Fontenot suggests the use of the owner's identification number for reporting purposes.

Some practitioners have requested a waiver from the duty to report. But the laws do not currently allow for waivers from reporting, only waivers for reporting electronically (i.e., dispensers would still have report by paper).

Mr. Fontenot also stated that if a prescriber dispenses no more than a 48-hour supply associated with a procedure no duty to report exists.

Mr. Fontenot closed by conveying that the White House 'Drug Czar' via spokesperson Jennifer Devalence contacted him regarding their concern over the amount of stimulant use in Louisiana, especially as indicated by overweight clinics. Louisiana is currently number three in the nation for stimulant use. Mr. Fontenot described the Louisiana Board of Medical Examiners' recent regulatory prohibition on dispensing doctors. Ms. Devalence was pleased with this action and praised the Medical Board for its proactive stance.

## **Demonstration of Database Management Program**

Mr. Fontenot gave a demonstration of the Program via internet.

## **Opportunity for Public Comment**

State Police representative Lt. Col. Genny May presented Arkansas Legislation, Act 256 (2005) and Act 508 (2007), as examples of efforts to control certain ingredients used to make meth and mandatory real-time log books where relevant products are sold.
