1. CALL TO ORDER

The meeting of the Red River Waterway Commission was called to order by Vice Chair, Commissioner Paul Fleming, in the Board Room of the Red River Waterway Commission Office located at 5941 Highway 1 By-Pass in Natchitoches, Louisiana.

2. ROLL CALL

Roll was called and a quorum was present. Others in attendance were asked to identify themselves and offer any comments they may have regarding the agenda. However, no comments were offered.

4. APPROVAL OF AGENDA

By motion of Commissioner Crutchfield, seconded by Commissioner Burrell, the revised agenda was unanimously approved. The revised agenda, under the Approval of Minutes, to read as follows: of the September 19, 2018 monthly meeting and October 09, 2018 special meeting. 5. APPROVAL OF MINUTES

By motion of Commissioner Burrell, seconded by Commissioner Crutchfield, the minutes of the September 19, 2018 monthly meeting and the October 09, 2018 special meeting were unanimously approved.

6. TREASURER'S REPORT

By motion of Commissioner Simpson, seconded by Commissioner Burrell, the Expenditures, Financial Statements, Investment Reports, & Fund Balance Report for the month of September 2018, were unanimously approved.

7. COMMITTEE REPORTS

a) Contracts

<u>Consideration of Colfax RV Park Picnic Shelter Repair Alternatives:</u> The Commission gave authorization to the staff in order to request proposals for the replacement of the two Colfax RV Park picnic shelters with presentation of said proposals at the November 2018 meeting.

Consideration of Approval of 2019 Contracts List: By motion of Commissioner Crutchfield, seconded by Commissioner Fletcher the Commission unanimously approved the 2019 RRWC Contracts list as presented.

b) Land Management, Legal Affairs & Affirmative Action

<u>Consideration of Approval of Leaseback Renewal/Pool 4, Tract 15 & Nicholas Realignment Tract 4/50 Acres:</u> By motion of Commissioner Sayes, seconded by Commissioner Simpson, the Commission unanimously approved renewal of the 5-year leaseback agreement on Pool 4, Tract 15 & Nicholas Realignment, Tract 4, containing 50 acres with Charles Leon Webb at a blended rate of \$12.70 per acre (\$10.00 per acre for the 41 acres of low-lying, wooded, free board and \$25.00 per acre for the 9 acres of agricultural land), annual lease amount of \$635.00 per year and \$3,175 for the 5-year term.

Consideration of Approval of Cooperative Endeavor Agreement/City of Pineville/Red River Atchafalaya and Bayou Boeuf Levee District/Pineville Bank Caving: By motion of Commissioner Sayes, seconded by Commissioner Crutchfield, the Commission unanimously approved the Cooperative Endeavor Agreement with the City of Pineville and RRABB with a maximum cost to the Commission of \$75,000.00 and a corresponding budget amendment in the amount of \$75,000.00.

Consideration of Request to Cancel Land Lease and Authority to Re-advertise/Hadden Ft.

DeRussy/Tracts 45, 46 and 47/235 Acres: By motion of Commissioner Sayes, seconded by Commissioner Deville, the Commission unanimously agreed to the request to cancel land lease and authorized staff to readvertise and re-bid. The Commission further stipulated that there be an insertion in the re-bid, and in all future leases, stating that the current "cancelling" lessee may not re-bid on said property at the next bid term.

c) Recreation

Recreation Area Status Report - Mr. Mike Boydstun highlighted the prepared report provided in the meeting packet, noting that there had been 138,000 visitors to the District recreation areas during the month of September 2018. Updated maintenance items include, but not limited to:

- Ft. Buhlow comfort station is at approximately 90% completion
- Fish re-stocking of the Red River has begun. Pools 1, 2 & 3 are completed. Re-stocking of Pool 4/Red Oak to take place November 01, 2018 and at Bishop Point November 08, 2018. Re-stocking is at a ratio of 80% Florida Bass: 20% Tiger Bass

d) Ports

Ports Update: Port Directors from the following Ports: Red River; Natchitoches; Central Louisiana Regional and Caddo Bossier were present in the committee meeting to update the Commission on their 2018 activities to date.

Consideration of Funding Request Caddo Bossier Port Commission/Handling Equipment: By motion of Commissioner Jones, seconded by Commissioner Burrell the Commission unanimously authorized staff to prepare and present a Cooperative Endeavor Agreement with the Caddo Bossier Port for the purchase of: two (2) manual coil grabs; one (1) telescoping/mechanical coil grab; one (1) magnet material handling system for steel billets; one (1) magnet system for steel slabs and one (1) 6-tine electro-hydraulic grapple in the amount of \$507,000.00 and funding to dredge Slack Water Harbor in the amount of \$320,000.00 in order to reopen accessibility to the Slack Water dock.

 - Ft. Buhlow Seawall project 8 to 10 feet of riprap has been placed along length of seawall to aid in stabilization

- 12. RED RIVER VALLEY ASSOCIATION Richard Brontoli with the Corps of Engineers updated the Commission at the October 16, 2018 Committee meeting, as he was unable to be present at the October 17, 2018 Commission meeting
 - Water levels by Sunday, October 21, 2018 may hit the "triggers" that are in place. May see this first trigger occurring in Alexandria
 - Appropriations bill signed October 01, 2018 funding the Corps for fiscal year 2019.
 However 1.5 million dollars was pulled out of dredging budget and reallocated. Corps is actively working on a way to recoup the 1.5 million through additional/other means of funding
 - The Water Resources Development Act (WRDA) bill will need to pass prior to January 01, 2019 or the process will have to start anew
 - October 23, 2018 Congressman Johnson of Louisiana and Congressman Westerman of Arkansas will be viewing the Red River waterway system beginning at the Caddo Bossier Port and concluding at Lock 5
