

AAHSD Regular Board Meeting Minutes November 20, 2023

 - Elizabeth West, Board Chair shared information of an article on All Terrain Track Chairs available at the Louisiana State parks.
 - Darce` Byrd inquired as to the wait list at the AAHSD clinics. The ED responded that he would gather that information for the Board.
 - Bambi Polotzola shared she attended the Governor's Outstanding Leadership in Disabilities (GOLD) Awards last week, noting various families from the Acadiana area were recognized in several categories.

7. Comments from the Executive Director:

a. CCBHC update:

- The process is going well. The self-attestation was submitted and reviewed by SAMHSA. SAMHSA requested more details and/or specifics and will be submitted to SAMHSA.
- Continuing to hire staff for the CCBHC pilot project.
- Waiting on the CARF pilot project survey report from their visit on October 31, 2023 November 2, 2023.
- ED attended a meeting and was informed AAHSD has received funding from an OBH grant/allocation in connection with AAHSD's contract with National Council for consultations. OBH has put together a learning collaborative with all of the CCBHC groups in the state.

- b. Same Day Access update:
 - The project is going well.
 - The target go live date is January 8, 2024.
 - Tynese Breaux, Practice Manager/Project Director, CCBHC is providing training to support staff and clinicians at all AAHSD clinics.
 - All staff training (clinical staff & intake staff) scheduled for December 4, 2023.
 - New postings and policy changes will be implemented for AAHSD clients.
- c. Crisis services update:
 - ED is scheduled to meet next week with various groups that may consider applying as Crisis Services providers and will keep the Board updated.
 - ED signed a letter of support for a group in the Acadiana area that will be applying/pursuing that system of care for the Child and Adolescent population.
- d. Board refresher training:
 - Planning training for the first quarter of 2024 with Kay Irby, AAHSD Board Liaison.
 - ED will inquire if the training will be in person or via Zoom.
