7. Comments from Executive Director

Brad informed the Board he has a meeting scheduled for tomorrow morning with LCG Mayor-President's Chief of Staff regarding the seat vacancy for Lafayette Parish to discuss Board member criteria.

I. Case presentation - with Troy Abshire

a. As to Treatment of Consumers - A particular crisis case from August 2024 was discussed, wherein, Brad was notified during that weekend by an organization that crisis services were needed for an individual. Brad notified Troy of the situation, and it was determined that the daughter of this individual was in the OCDD system and then notified providers of the situation. Arrangements were made to assure the safety and welfare of the client were met. It was explained by both Brad and Troy how the providers that were contacted for assistance worked well together with AAHSD to assure the client's needs were met and noted how the programs in place are successful. The client is currently living independently and is thriving. Updates were also given regarding the mother of the client.

II. Data reports update

a. This is a project that is active and ongoing. AAHSD has included the State in the meetings with the EHR vendor, and is making progress; noted the troubleshooting and technical errors in the EHR system that are being addressed; and continue to work with OBH and the EHR consultant.

III. CARF survey

a. Brad reported the CARF surveyors will be at AAHSD from August 25-27, 2025 for the annual survey.

IV. Act 351 overview

a. Brad explained Act 351 and Act 419 and the effects it could have on AAHSD services. Discussions were held.

Brad informed the Board he will be meeting with Louisiana delegates Thursday morning, August 21, 2025, at the Ville Platte clinic (Evangeline Parish) to discuss CCBHC.
