There were no oppositions. The February 2022 minutes were approved.

GOHSEP UPDATES

Casey Tingle, Director

- Legislative Session began on March 14, 2022. The following Bills were discussed:
 - **HB 291 Representative- Francis C. Thompson**-Nursing Homes: requires all nursing homes to maintain in effect emergency preparedness plans approved by the LA. Department of Health.
 - HB 933 Representative- Joe Stagni- Nursing Homes: Provides relative to emergency preparedness among licensed nursing homes
 - HB 167 Representative- Phillip DeViller- Tax/Severance Tax: reduces the severance tax rate for oil over a certain period of time and specifies the severance tax rate for oil produced from certain wells
 - HB 606 Representative- Brett Geymann Legislative Committees: Creates a legislative oversight committee to oversee and set priorities for the expenditure of federal monies received by the State for Emergencies and Disaster Recovery
 - HB 759- Clay Schexnayder- Emergency Preparedness: Provides relative to the Governor's Office of Homeland Security and Emergency Preparedness HB 759 Bill will go before the committee on April 28, 2022

- **HB 1052 Representative- Mandie Landry-** Funds/Funding: Establish the Hazard Mitigation Revolving Loan Fund
 - Moves out of the House Appropriation to Full House
 - \$500 million funding over a 5-year period
- GOHSEP Budget for FY23 and FY22 Supplement Request
 - \$1.5 million for an LWIN tower in Thibodaux added in the budget
 - Two additional positions have been added
 - Current year FY22 Supplemental Budget
 - FEMA Cost Share for IA Events and Mission assignments that we have bills for and need to pay
 - PA Cost Share for older events
 - The additional \$6.9M for the LWIN Ethernet project has not yet been added. We anticipate an amendment in the Senate.
- **New FY23 Ear Marks** from Congress for Pre Disaster Mitigation and Emergency Operation Center grants. Deadline ends this week.
- Shift Current -FMA funding take homeowners that was impacted by Ida that need mitigation.
 - \$60 million in funding was allocated nationwide and \$40 million of the funds would awarded to Louisiana
 - Substantial Damage Properties
 - o Deadlines for round one is May 1, 2022 and round two will be July 2, 2022
 - Cost Shares in the President's bill. The Cost share for 2020-2021 disasters has been changed to 90-10.
 - Working with OCD on CBDG for use as a match for PA cost share for Laura and Ida. OCD is putting together their action plan.
 - GOHSEP currently has about 5,200 in temporary housing. FEMA has set the current deadline for Temporary housing for the beginning of September.

2022 Non-Disaster Preparedness Grants

EMPG FY22

- Louisiana Amount to receive \$6,415,373
- This is a one-time increase for FY22 by \$792,021
 - Note: The increase is a onetime supplemental, not expected in FY23.
- Application Period: April 13 June 13, 2022
 - The new national priorities for the FY 2022 EMPG Program are
 - Equity
 - Climate Resilience
 - Readiness
 - These should be factored into investments across national priority areas but are not a mandatory requirement until FY23.
 - The State is looking at the same priorities as last year for FY22:
 - Planning
 - Operational Coordination
 - o Emergency Communications/Operational Communication
 - Logistics Distribution Management/ Logistics and Supply Chain Management
 - Organization
 - EMPG Other Investments

HSGP FY22 includes SHSP, UASI, OPSG, and NSGP:

- NOFO will be released no later than May 13th
- FY22 SHSP Risk Changes
- (6) Priority Areas
 - Soft Targets/Crowded Places
 - Intel Sharing
 - DVE, Cyber Security
 - Community Preparedness

- \circ Resilience
- Election Security
- (3%) minimum of spending is required towards these areas (totaling 12%)
- Remainder (18%) can be re-allocated toward the other priority areas
- IJ is not required for Cyber Security & Election Security unless allocation being made toward these priorities
- **LETPA** is being increased to (30%)

NSGP FY22:

- Overall increase to Grant from \$90 million to \$125 million so Louisiana anticipate an increase
- NOFO will be released no later than May 13th
- Expect only a State grant, not a UASI
