#### **GOHSEP UPDATES\ REPORTS**

Casey Tingle, Director

- FY 2023 EMPG allocation increase for parishes was discussed and is supported by the Governor to update GOHSEP budget for State FY 2023-2024.
- Chris Guilbeaux Retirement effective January 20, 2023
- John Long, FEMA Federal Coordinating Officer (FCO), Retirement
  - Benjie Abbott taking over as FCO moving forward.

- Started to look internally at evacuation and shelter planning across the state. Reevaluating assumptions from the past few years. Also, working to identify new shelter space (large facility in Shreveport).
- GOHSEP will be working to close out Hurricane Rita activities and Hurricane Ike activities in 2023.

## **Public Assistance Updates**

- 12/31 deadline to submit expenses for COVID-19 that were incurred prior to July 31, 2022 in the FEMA Grants Portal. Please submit individual extension if needed.
- There is a glitch in the Sam.gov system for some applicants in registering for a UEI.
- Deadline to come to a Fixed Cost Agreement (Sec. 428) for Ida Public Assistance is February 28, 2023.

## **Hazard Mitigation Updates**

- Disaster Grant open application periods are the only time to submit projects.
   Laura and May Flooding closed last month. Delta, Zeta, and Winter Weather closes in the next two weeks.
- Building Resilient Infrastructures and Communities (BRIC) and Flood Mitigation Assistance (FMA) application periods close January 27, 2023; all applications due to GOHSEP December 19, 2022.

#### **Grants and Administration Updates**

- GOHSEP Grants Portal applications are due for FY22 awards. Latest extension approved thru December 23<sup>rd</sup>. Need everyone to get these applications submitted ASAP.
- Contractor is finalizing the code changes for the quarterly reporting and reimbursement process. Training to come.
- GOHSEP meeting with Starlink to answer frequently asked questions on funding, installations, etc.
