## 2022 Non- Disaster Preparedness Grants Updates

 Christina Dayries presented three scenarios for the FY2022 EMPG annual allocation to the parishes for the subcommittee for review. She recommended to continue the allocation of \$25,000 base amount per parish with the remaining based on population.

- There were no oppositions. The recommendation for the FY2022 EMPG allocation to the parishes of \$25,000 base amount per parish with the remaining based on population was approved.
- She also discussed the one-time \$792,000 in FY2022 EMPG funding, which
  comes with a 50% match requirement and recommended the subcommittee
  consider a backup communication system to LWIN/WebEOC similar to a Starlink
  solution. The funding would support all State/Local EOCs and other critical
  facilities communication in addition to other AuxCom technology.
