APPROVAL OF MINUTES from September 2025

There were no oppositions. September 2025 minutes were approved.

GOHSEP Updates/ Reports

Brig. Gen. Jason Mahfouz

- 2025 Legislative update:
 - Act No. 262 passed with nine amendments. This act formally transfers the GOHSEP under LMD
 - The “We will Act” Act passed addressing counteractions involving Unmanned Aerial Systems (UAS).
 - Louisiana State Police (LSP) will be the lead agency for the state.
 - The Attorney General’s Office will collaborate with District Attorneys in each jurisdiction for implementation and enforcement.
- GOHSEP/LMD merger updates:
 - State agencies have been directed to implement an additional 10% in State General Fund expenditures.
 - Phase 1 of the merger is complete.
- FEMA updates:
 - Proposed structural reforms to FEMA will come down in three waves.
 - Wave 1 (less than 6 months): this phase focuses on quick, internal administrative changes to rebalance FEMA’s role in disaster response.
 - Narrowing of focus: reduce the number and costs of disaster declarations, concentrating federal resources on large-scale events
 - Focus on core function: encourage states to take more responsibility for smaller, localized events
 - Accelerated assistance: streamline program administration to accelerated funding for emergency work
 - Wave 2 (6-12 months): will likely require additional regulatory or administrative adjustments to advance reform goals
 - Process overhaul: implement universal application to simplify process for survivors
 - Program modernization: reduce red tape
 - Mitigation incentives: implement new funding opportunities for resilience projects
 - Wave 3 (1-3 years): will likely require congressional legislation
 - Cabinet-level status: return FEMA to cabinet-level independent agency
 - Mitigation focus: shift agency’s focus towards proactive hazard mitigation and resilience
 - Resource rebalancing: potentially moving federal dollars to state-managed block grants for recovery
 - The final report should be released around the second week of December. It will be on the federal registry for public comment for a period of 30 days.

- Preliminary injunction was issued on August 5, 2025, blocking the administration from reallocating funds from the BRIC program
- PA reform proposal to move to flat 75/25 cost share, currently receiving lots of pushback.
 - PA reform also includes a new standard for recoupment that would be based strictly on the definition of criminal fraud.
- FY25 Preparedness grants on hold right now.
 - All states have a requirement to validate census data and to verify that the census data does not include persons who were deported from each State of Louisiana
- UASI funding zeroed out for Louisiana
 - Encouraged those affected to reach out to their elected officials to elevate their concerns

Public Assistance Updates

Brittany Humphries, Section Chief of Public Assistance

- Wrapping up 2023 Wildfire Disaster
- Three important thresholds:
 - State's PA threshold increased to \$9M; Parish PA thresholds increased- should have received an email with new threshold amounts
 - Small project threshold increased to \$1,093,800.
 - Minimum amount for a project was increased to \$4,100

Recovery Operations Updates

Allison Saari, Asst. Director of Recovery Ops

- Currently have six SBA disaster declarations ongoing
- Non- congregate sheltering- down to 2 trailers in the State of Louisiana
- Direct housing mission- down to 10 in the State of Louisiana

Hazard Mitigation and Preparedness Updates

Sandra Gaspard, Assistant Director of Hazard Mitigation and Preparedness

- FY25 Awards made, with funding hold for RFIs.
 - FEMA HQ Preparedness Grants staff are currently furloughed
 - FEMA GO is unavailable at the time.
- DR-4817, Hurricane Francine: applications due to GOHSEP by November 13, 2025
- GOHSEP Grants enhancements will not go live until GOHSEP does additional user acceptance testing.
 - invites all to participate in testing
 - FY22 HSGP (SHSP, OPSG, UASI) POP extension request pending with FEMA

- FY21 SHSP closed at the end of August- processing final payments
- ***Performance period on all FY25 grants is one year- October 1, 2025- September 30, 2026***

Financial Operations and Administration Updates

Neal Fudge, Deputy Director

- GOHSEP has assumed responsibility for the contracting component related to the Smitty's incident.
- Reiterated that all FY25 grants will have a one-year period of performance

Emergency Management Updates

Mark Ward, Asst. Director of Emergency Management

- Current incidents:
 - Salt-water intrusion: low-water seal completed on October 10th to protect Belle Chase and areas to the north
 - Drought: 14 burn bans currently in place across the State of Louisiana
 - Invest 98L: monitoring

Security and Interoperability Updates

Euclid Talley, Asst. Director of Security and Interoperability

- School safety grant- 131 schools/districts awarded \$50,000
- NAV360 is active, increasing coverage around the state for anonymous reporting
- 46-47% increase in Motorola maintenance costs- GOHSEP looking to improve future contracts for big projects
- RAVE Panic button- one-year contract signed on 8/12/2025.

Cybersecurity Updates

Stephen Durel, Assistant Director of Cybersecurity Incident Response

- Louisiana Cyber Assurance program
 - Assessments are being conducted statewide. To date, 188 out of 472 assessments have been completed, with 11 currently in progress. Of the completed assessments, 110 critical vulnerabilities have been identified.
- Approximately 139,000 endpoint detection software installations are deployed across state networks to help protect against intrusions.
- Significant increase in cyber events; many are suspected threats into state networks
