# 1. Consideration: Approval of May 12, 2020 Minutes

The Chairwoman asked the Board for a motion for the approval of the May 12<sup>th</sup> minutes. Parish President Kirk Lepine made a motion to approve the May 12, 2020 minutes, seconded by Councilmember Julia Fisher-Perrier. Based on the poll, this item is approved by the Regional Planning Commission members in attendance, as noted by the Chairwoman.

Citizen, Mr. Chriss Cazayoux of St. Tammany, asked does any entity in the RPC, or does the RPC plan on submitting for the U.S Dept. of Labor, Employment & Training Administration, WORC grant. Maggie Woodruff, RPC Economic & Development Director, told him that RPC is working with our community colleges like Delgado and Nunez who can be applicants and provide apprenticeship training for private sector jobs and that she will follow up with him.

The Chairwoman asked if there was any other public comment. There are no other public comments at this time and we can move to the next item.

#### 9. Consideration: Other Matters

Mr. Chris Masingill made a motion to adjourn the meeting, Mr. Lee Giorgio seconded and based on the poll the motion to adjourn the meeting is approved unanimously by the Regional Planning Commission members in attendance, as noted by the Chairwoman.

Also Mayor Cantrell urged the Mayors, Parish Presidents and RPC to submit their application for the Cares Act Grant from the State for their expenses and that there were new guidance, the City of New Orleans had submitted their application on April 30<sup>th</sup> and got a response from the development team whose managing their request, she urges all to move forward with applying for the grant, she stated there was some expectations that the money allocated would not be able to be spent and that she is pushing back on that because the guidelines now allow us to deal with the payroll expenses. She stated that the bottom line is to do what it takes to get our fair share of the dollars. Parish President Cynthia Lee Sheng of Jefferson parish mentioned that she received an email from a person putting in a submittal that came back from the State with 9 points to clarify with a 2 day turn around by Thursday. Mayor Cantrell replied that the State wants the documentations sooner than later and extended her support so that we can get the fair share of dollars.
