LICENSED SPECIALIST IN SCHOOL PSYCHOLOGY
ADVISORY COMMITTEE
MEETING MINUTES: September 13, 2016**

FINAL APPROVED: December 13, 2016

The Licensed Specialist in School Psychology Advisory Committee [herein Committee] of the Louisiana State Board of Examiners of Psychologists [Board] was noticed and agenda posted September 12, 2016. Dr. Carmen Broussard, called the meeting to order at 1:35 p.m. at 8706 Jefferson Highway, Suite B, Baton Rouge, LA 70809. Present were Committee Members, Dr. Carmen Broussard, Dr. Amy Childress Morvant, and Ex Officio Member, Ms. Jaime Monic. Dr. Steven Welsh was absent from this meeting

Dr. Broussard moved to approve the meeting agenda, the motion passed unanimously.

The committee reviewed the minutes from June 14, 2016. Dr. Morvant moved to approve the minutes. The motion passed unanimously.

The Committee welcomed Dr. Amy Morvant, newly appointed committee member. Dr. Broussard provided an overview of the meetings and training on file reviews. The Committee briefly reviewed licensing requirements for LSSP's.

FILE REVIEWS [LSA-R.S. 42.6.1]:

The Committee reviewed the Application for Licensed Specialist in School Psychology of **Connie Cassels, SPP.**, finding that the requirements for licensure have been met, Dr. Morvant moved that the Committee confirm the Candidacy status of **Ms. Cassels** and recommend her to the Board for licensure as a Specialist in School Psychology pending receipt of passing Jurisprudence Examination. The motion passed unanimously.

The Committee reviewed the Application for Licensed Specialist in School Psychology of **Carey L. Day, SPP.**, finding that the requirements for licensure have been met, Dr. Morvant moved that the Committee confirm the Candidacy status of **Ms. Day** and recommend her to the Board for licensure as a Specialist in School Psychology pending receipt of passing Jurisprudence Examination. The motion passed unanimously.

The Committee reviewed the Application for Licensed Specialist in School Psychology of **Jason Talbot, SPP.**, finding that the requirements for licensure have been met, Dr. Morvant moved that the Committee confirm the Candidacy status of **Mr. Talbot** and recommend him to the Board for licensure as a Specialist in School Psychology pending receipt of passing Jurisprudence Examination. The motion passed unanimously.

DISCUSSION:

Ms. Monic updated the Committee that the Board approved language regarding supervision requirements for LSSP under the LAC Title 46, Part LXIII. Ch 33, and that rulemaking would begin around November 2016; and that the Board approved the new LSSP Reference Forms, already being utilized in new applicant material.

Dr. Broussard reported that the Louisiana School Psychologist Association would be holding its convention on November 3, 2016 and they have asked the LSSP Committee to present on the LSSP credential and licensing process. Ms. Monic agreed to help provide stats and confirm the presentation with the LSBEP.

Dr. Broussard moved to adjourn the meeting at 2:30p.m. The motion passed unanimously.
