## Meeting Minutes Thursday, March 13, 2025

- 1. <u>Update on Rule Revisions</u> Ms. Monic updated committee members that Chapters 31, 32 & 33 of the La Administrative Code, 46:XIII regarding LSSP Applications and Committee Composition had been filed, was moving through the process and is anticipated to be final on April 20, 2025.
- 2. <u>Future Meetings (Date/Time/Location)</u> Dr. Hebert offered to continue to request meeting space to host LSSP Committee Meetings at LSUHSC. Committee members discussed future meeting dates and confirmed the following: June 4, 2025@ 1:30pm, September 3, 2025 @1:30pm, and December 3, 2025 @1:30pm.
