I. OPEN MEETING

Call to Order

The meeting of the Licensed Specialist in School Psychology Advisory Committee ("Committee") of the Louisiana State Board of Examiners of Psychologists ("Board") was called to order at 1:35 p.m. by Dr. Katherine Chenier, Committee Chair.

II. REVIEW AND APPROVAL OF AGENDA

IV. DISCUSSION ITEMS

1. Updates

a. Rule Revision to Application Workflows

The Committee received an update that revisions to streamline the LSSP application workflow for both legacy and standard applicants were finalized on April 20, 2025. Suggestions were made that revisions to the Steps Toward Licensure for LSSP's would be needed to align with new workflows.

b. LSSP Continuing Professional Development – Supervised Practice Plan Form

The Committee received an update that the form approved to document LSSP supervision for preapproval of CPD for supervision activities had been published on the website. The Committee discussed the update and identified a roadblock to licensure for LSSP's due to limits set by LDOE that prohibits employment of trainees unless they have a license...thereby removing an opportunity to allow training within a school system. The committee discussed a potential solutions including a) to amend R.S. 37:2356.3.A(1)(g) and remove the term "certified school psychologist" and/or b) for LDOE to extend provisional licensure so a trainee could have access to training.

c. 2025 Call for Nominations

The Committee was updated that no self-nominations had been received to fill the upcoming vacancy occurring June 30, 2025. Dr. Chenier affirmed that July 1, 2025 and would be her last meeting and moved to nominate Ms. Kelley Pursell for the position of Chair of the LSSP Committee effective immediately. Following opportunity for discussion, the motion passed unanimously by roll call vote as follows:

3. <u>Conduct comparison review of requirements to receive National Certification in School Psychology vs. Louisiana Licensed Specialist in School Psychology.</u>

The Committee reviewed the previously drafted comparison of national vs. state credentialing standards. The Committee identified areas where the document needed updating in light of recent revisions to LDOE's credentialing and LSBEP's updated regulations. Ms. Monic agreed to share an editable draft with the Committee so revisions could be proposed and discussed at their next meeting in September.

4. Continue to review and update regulations:

a. Telesupervision for LSSPs

This item was tabled until September 3, 2025.

b. Chapter 40 - Continuing Education

Following additional draft revisions made by the Board to continuing education for licensed psychologists (Chapter 8), the Committee reviewed a second revision to Chapter 40 (continuing education for LSSP's) which draft aligned with the Committee's goal of being consistent with Chapter 8.
