# 4. Reports

A. RTA Chairman's Report

Commissioner Raymond stated that the 15th Annual ADA/Senior Hurricane

Emergency Preparedness Meeting was held and the lessons that was learned with Hurricane Ida was shared at this meeting. The RTA played a variable part in evacuating the Senior/Nursing Holmes around the City when the power was lost.

Commissioner Raymond stated that the Board will have a summer retreat and should have a date at the June Board Meeting.

#### B. Operations & Administration Committee Chairman's Report

Commissioner Neal stated that the Summer Pick was presented at the Operations Committee Meeting and at the RAC Meeting staff received a lot of feedback from the riding public regarding bus service and at this meeting there will be an update on the Temporary Signage.

#### F. RTA Chief Executive Officer's Report

Lona Hankins reported that the RTA had its Hurricane Preparedness Meeting with the Community, and the RTA signed the CEA with the City of Kenner for Hurricane Preparedness.

Lona Hankins reported that the IBEW Contract expires at the end of June and staff was still negotiating the contract terms. Also, Management is fully aware that some ATU employees are due retro pay and staff was working on those payments to make sure that all payments were accurate.

Lona Hankins reported that the Summer Schedules are available for the June 4, 2023 Summer Service Adjustments.

Lona Hankins reported that the Temporary Signage has been delivered and are being place around the City and the Permanent Signs are on order and staff has to figure out a Long Term Signage Strategy.

Lona Hankins reported that the Operator of the Month was Joseph James, and the Maintenance Employee of the Month was Emile Fisher.

#### G. Chief of Staff Legislative Update

Katherine Felton, Chief of Staff gave the Legislative Report. This report can be found in the Board of Commissioners PowerPoint Report dated, May 23, 2023, under the Chief of Staff Legislative Update Report.

In response to Commissioner Ewell, Lona Hankins reported that she believes that the City Council was going to start a pilot program for youths to ride the system for free, but the RTA can't afford to go to zero fares for the youth. The RTA has already reduced the fares for the youth and the RTA will have a meeting with the Council to discuss all the details.

Commissioner Walton stated that today the City Council was creating the fund for this program and will take a vote on this item at Thursday's Meeting.

Commissioner Raymond stated that the Council intention was to have the RTA at the table to discuss this program.

Commissioner Raymond stated that May was Mental Awareness Month and RTA has placed Pause, Breath Signs with a QRCode on all the buses.

#### H. Operations Update

Christopher Clark presented the RTA's Chief Transit Officer's Report. This report can be found in the Chief Transit Officer's PowerPoint Report dated, May 23, 2023, under the Chief Transit Officer's Report.

Christopher Clark reported that staff was aware of the environment that the Operators has to function in on a daily basis, and has taken into consideration that the operators can have personal issues going on in their lives, so staff is taking the time to teach the operators to better compartmentalize their issues.

#### I. RTA Chief Financial Officer's Report

Gizelle Banks presented the RTA's Chief Financial Officer's Report. This report can be found in the Chief Financial Officer's Report PowerPoint Report dated, May 23, 2023, under the Chief Financial Officer's Report.

In response to Commissioner Raymond, Gizelle Banks reported that what was on the report was the interest from the Bond Funds.

In response to Commissioner Coulon, Gizelle Banks reported that the RTA was never fully staffed and always has vacancies.

In response to Commissioner Raymond, Ryan Moser reported that staff was working on a staffing plan to meet service and get training for staff and next month some Procurement Items will be brought before the Board for solutions that will result in Blanket POs.

Lona Hankins reported that funding will be obligated by FTA to allow staff to order the hybrid vehicles and additional Paratransit Vehicles.

Lona Hankins reported that staff would like to request an emergency procurement to bring in traveling mechanics to help with fixing the buses.

In response to Commissioner DeFrancesch, Ryan Moser reported that you can get steel parts, but was having problems with electronic parts.

In response to Commissioner Coulon, Lona Hankins reported that once staff was out of critical mode, then she would like to introduce a private vendor that would house the necessary parts that the RTA would need.

Commissioner Ewell stated that the RTA needs parts and the RTA need to address this issue immediately.

Commissioner Raymond stated that this was an important discussion to have so that the public could understand the RTA's issues.
