    - Short Term Spraying: 1 contract spraying since last meeting, and some spraying on buck brush in Little Lake, need more and to include Coulee Drainage area as well..
    - · Salvinia Evaluation / Problem Areas: New Cypress tree growth is a problem in numerous spots on the lake. No plan to spray the new growth until water starts coming up. Coulee Flat and north of Cedar Bluff are two areas of concern. Salvinia south of pipeline is manageable at drawdown level, up the lake is still a problem as access is limited.
    - · Drawdown reached maximum drawdown level very quickly and has maintained that low level due to drought conditions
    - Pipeline Boom was released by unknown party, LDWF reattached. They will add new plastic corrugated section at channel for boats to slide over.
