BUSINESS ADMINISTRATION

LSRT March Meeting, Shreveport, LA

Chairman explained the current process of reimbursing board members that attend LSRT meetings and opened for discussion. Reimbursement process will be added to the Board's Operational Manual.

Board Operations

- Chairman reported that Counsel had reviewed the Board's IT Policy, no changes are required.
- Counsel suggested disclaimers should be placed on the LSRTBE website. Executive Director will work with Counsel on wording.

Executive Director reported:

- Lasers 2015-2016 contribution rates will increase from 37% to 37.2% of gross salary.
- 3669 licenses will require renewal by May 31, 2015.
- Executive Director explained the problems with his current computer. Computer requires replacement along with upgrading the software of all office computers for compatibility. F1 Solutions provided a quote to upgrade office computers. N.Awan suggested contacting their hospital's vendor for possible help. Board agreed by voice vote to purchase new computer and upgrade IT software of all computers.
- Dr. Hugh Robertson resigned. A physician replacement must come from the Louisiana Medical Society.
- Transfer of Capital One funds to the operating account.
- Letters will go out to the CEO's of LHA facilities as a reminder of license renewals.
- Capital One issues discussed at the previous meeting have been resolved.
