NONVERBATIM MINUTES OF THE MEETING OF THE BOARD OF TRUSTEES, SHERIFFS' PENSION & RELIEF FUND, HELD AT THE LOUISIANA SHERIFFS' PENSION FUND OFFICE IN BATON ROUGE, LOUISIANA AT 9:15 AM WEDNESDAY, JULY 24, 2024.

The meeting was called to order, and everyone was welcomed by Sheriff Willy Martin, President. An invocation was offered by Ronnie Morse and Sheriff Jay Russell led the Pledge to the American Flag. Roll was called and those in attendance represented a quorum.

Others in attendance for the meeting included Joey David, Legislative Analyst; Greg Curran, Actuary, Curran Actuarial Consulting; Jason Windham, Shobe Financial; Bob Klausner, Legal Counsel (through conference call) as well as several active and retired parish representatives and Pension Fund staff members Chris DeWitt, Betty Sibley and Katie Thiebaud.

Though not in attendance, the Director acknowledged new ex-officio Board members: Senator Caleb Kleinpeter and Representative Roy Daryl Adams, and thanked them for their help during the Legislative Session. He also acknowledged Laura Gail Sullivan for her assistance in drafting the LSPRF legislation for this year's session.

Next on the agenda, Director McGee and Assistant Director Chris DeWitt gave a performance report and asset allocation update and included reasons for optimism and causes for concern going forward. The following estimated returns (Net of Fees) were reported:

- Fiscal Year Ended 6/30/2024: 12.1%
- Market Value of Assets Increase of \$496,090,876.27
- Market Value of Assets at Fiscal Year Ended 6/30/2024: \$5,059,714,751.89
- Fiscal Year to Date Return (July 1 through July 19th): 1.1%

Their asset allocation review reflected the Fund's diversification and total assets at 07/19/2024 totaling \$5,113,405,791.59

Next, Paul Eitleman, Russell Senior Investment Strategist, North America Division, joined the Board meeting through conference call to give a global economic and market outlook update. These discussions assist the Board in planning investment strategies for the future. Ronnie Morse then gave the following Executive Committee Report: The Executive Committee met with Michelle Cunningham and Patrick Butler, partners of the Fund's auditing firm Duplantier, Hrapmann, Hogan and Maher on Wednesday, June 26, 2024.

Members of the Committee were all present for the meeting: Ronnie Morse, Chairman, Don Rittenberry, Vice Chairman, and Osey McGee, Executive Director. Staff present for the meeting included Chris DeWitt and Betty Sibley.

Michelle reviewed the report with the staff. It was of the auditor's opinion that the financial statements presented fairly, in all material respects, the respective financial position of the fiduciary activities of the Sheriffs' Pension and Relief Fund as of June 30, 2023 and 2022, and of the respective changes in financial position for the years then ended in accordance with accounting principles generally accepted in the United States of America.

Michelle stated that it was a "Clean, unmodified opinion." Page 70 of the audit report lists a summary schedule of findings and reflects the following:

Summary of Auditors Results:

- The opinions issued on the financial statements of the Sheriff's Pension and Relief Fund for the years ended June 30, 2023 and 2022 were unmodified.
- Internal Control over financial reporting: Material weaknesses: None noted
 Significant deficiencies: None noted
- 3. Compliance and other matters: Noncompliance material to financial statements: None noted <u>Findings required to be reported under generally accepted governmental</u> <u>auditing standards:</u> None

Management letter comments: None Summary of prior year findings: None

The Director thanked Michelle and Patrick and their firm for the Fund's long-term relationship, the thorough job they do, and the assistance they provide when needed. Michelle complimented the Pension Fund staff.

That concluded the audit report.

With no further questions or business to consider, that concluded the meeting of the Executive Committee.

Director McGee also took time to recognize Director of Accounting, Betty Sibley,

for her outstanding job working with the auditors for the Fund.

Richard Corbett made a motion to accept the Executive Committee Report. Joe Seymour seconded and the motion passed unanimously.¹

Moving on to legislative matters, the Director first reviewed with the Board the approved and passed legislation for the LSPRF, as follows:

- Senate Bill 415, Act 349 by Senator Ed Price changes current law from allowing retirees to earn 50% to 55% to 60% to 65% with a 4 year sunset provision. At the new percentage allowance, employer and employee contributions must be paid, but this law shall not result in additional service credit and the employee can refund their contributions. To qualify, the employee must have been retired by January 1, 2024.
- House Bill 752, Act 271 by Representative R. Dewith Carrier increases the membership threshold from \$1000/month to \$1250 a month to assist sheriffs' offices with part time employees.
- Senate Bill 405, Act 346 by Senator Caleb Kleinpeter allows for retirees to rescind their retirement and come back to work full-time and earn a benefit based on their current salary rather than a supplemental benefit. To do this, the employee must pay back in a single lump sum all benefits paid out to them, including back drop, plus interest at the assumed rate of return. This bill also has a sunset provision and will expire in December 2027.
- Senate Bill 406, Act 347 by Senator Caleb Kleinpeter takes the cap off Permanent Benefit Increases for those who have been retired for 30 years or more.

Director McGee explained that the goal in this legislation was to assist the Sheriffs and the LSA to help them bring back experienced personnel to help with recruiting problems that many sheriff's offices are facing. He thanked Senator Price, Senator Kleinpeter, and Representative Carrier for authoring the bills and for their invaluable help during the session.

Moving on, Curran Actuarial Services contract was reviewed. Ronnie Morse made a motion to approve of the contract and Joe Seymour seconded the motion. It passed unanimously.²

Next, the Director discussed upcoming events:

- 1. The LSA conference being held July 28 August 1 in Destin, Florida
- 2. Trustee Education Seminar August 26 28th at L'Auberge in Baton Rouge for the Board to complete their 16 hours of educational training required by law.

Legal Counsel Bob Klausner stated that there was no executive session needed.

For the final order of business, Joe Seymour made a motion to approve of the March 20, 2024 Board Meeting minutes and the applications for reciprocal recognition of service, transfers, retirement, BackDROP, disability, and survivor benefits. Victor Jones seconded the motion and it passed unanimously.³
