Mr. Yett reviewed a potential alternative investment Bridgepoint Europe V, L.P.

BAKER, AND CARRIED, consistent with the alternative investment guidelines, the Committee voted to receive the Hamilton Lane report, including the due-diligence process dated August 4, 2014, pertaining to investments in Bridgepoint Europe V, L.P. (up to \$75 million), subject to final term negotiations completed within the timeline established by the Hamilton Lane contract.
