Ms. Westgard asked that Mr. Yett provide a written summary of his response.

## **Update on Meetings**

Ms. Westgard updated the Committee on the Public Retirement Systems Actuarial Committee (PRSAC) meeting of January 21, 2016. TRSL's valuation was approved. TRSL and LASERS agreed to continue to study the reduction of the discount rate.

#### **Update and Discussion of 2016 Legislative Sessions**

Ms. Westgard updated the Committee on the following:

- <u>Public Notices Affecting State Systems</u> that have been filed since TRSL's January meeting.

## • Legislation Affecting TRSL

Ms. Westgard noted that Representative Ivey requested to present information on his prefiled bills to the Committee.

Representative Ivey stated that his package of bills address pension reform. He also noted that the bills as filed are a starting point and that he is willing to work with any interested party on suggested changes. Representative Ivey reviewed the bills. He noted that HB65, which would establish a new hybrid retirement benefit structure for members of state retirement systems first hired on or after July 1, 2018, is his primary focus. Ms. Westgard requested if Representative Ivey would share his actuarial modeling information with TRSL when the information is complete, it would be very helpful.

Dr. Baudin noted that the Committee would not take positions on legislation until the March meeting in order to have complete actuarial, legal, and administrative analysis of the bills affecting TRSL.

Ms. Westgard and Ms. Whitney reviewed prefiled legislation affecting TRSL as of February 5, 2016.
