Legislation Affecting TRSL

Ms. Westgard reviewed prefiled legislation affecting TRSL as of March 2, 2017.

Senator Peacock reviewed his bill, **SB 11**, which provides for incorporation of the Louisiana School Employees' Retirement System (LSERS) into TRSL. He also reviewed **SB 8**, which provides for correction of membership and enrollment errors in the state and statewide retirement systems.

Representative Pearson reviewed his bill, **HB 33**, which provides relative to representation of the House of Representatives on the boards of trustees of state and statewide retirement systems.

Ms Westgard reviewed bills related to Return to Work: **HB 4** by Representative Miguez which provides relative to the reemployment of retired school nurses in positions covered by TRSL; and **HB 31** by Representative Hoffmann which provides relative to the reemployment of retired school psychologists in positions covered by TRSL.

Ms. Westgard noted that the Committee would not take positions on legislation until the April meeting in order to have complete actuarial, legal, and administrative analysis of the bills affecting TRSL.
