Change Order No.7 : Add \$616.60 for hose bibs and piping Change Order No.8 : Add 47 days to the Construction Period for fire proofing, etc. Change Order No.9 : Increase of Museum Project Budget by \$107,317.00 bringing the Total Budget to \$1,525.880.45
