Regional Military Museum Foundation: Report by Mart Black:

- 1. The Museum has received 369 guests since the last meeting. This puts the museum at 1,736 guests since we reopened in June 2020 (not including Memorial Day). This number includes a summer camp group of 101 kids.
- 2. Current grants received to date \$15,000
- 3. Atchafalaya National Heritage Area awarded the RMM \$7,500 for a project entitled "French-speaking Cajuns of World War II Interviews and Stories."
- 4. The RMMF Board considered a proposal from Bluewater Rubber and Gasket to purchase property behind and on the north side of the shop; the Board declined the offer.
- 5. Main shafts on the lathe have been reinstalled and testing will begin shortly.
- 6. Lighting on the 3<sup>rd</sup> floor has been completed
- 7. One of the commemorative jeeps donated has been purchased.
- 8. The machine shop on the north side of the RMM will be up for sale later this year
