10 hearing.

12 Is there anyway that you can write it
13 down for me?

16 before you leave.

17 MR. POTEET:

18 We apologize. We have several members of
19 the Commission that are out sick today, and we have
20 to have a quorum to conduct business so that
21 requires 6 of us to be here, and there are only 4 of
22 us.

23 MR. GUILLORY:

24 I explained to her previously, she has
25 daily rentals, ongoing daily rentals, and those

1 rentals she can continue to collect on those
2 rentals, but not to go into any new contracts until
3 that time.

4 MR. HALLACK:

5 That's correct.

7 That is it.
