Financial Matters

There were no questions regarding financial reports reviewed by the Commissioners. Motion was made by Finance Chairman Brown to accept the financial reports as presented, seconded by Commissioner Pederson. With no further discussion, the motion was passed unanimously.

2. Amended FY 2024/2025 Budget

Rhonda Robertson presented the amended operating budget for FY2024/2025. Ms. Robertson informed Commissioners that she had worked close with Roy Hebert, CPA commission contractor to review, make corrections, and update the previously presented Operating Budget for FY2024/2025. There were no questions regarding the Amended Operating Budget for FY2024/2025. Finance Chairman Brown made motion to accept the Amended Operating Budget for FY2024/2025 as presented, seconded by Commissioner Donnell. With no further discussion, the motion passed unanimously.

3. Amended Resolution Adopting Fiscal Year Operating Budget (FY 2024/2025)

Rhonda Robertson presented the Amended Resolution Adopting Fiscal Year Operating Budget for FY 2024/2025 Resolution adopting the fiscal year operating budget for 2024/2025 was presented by Rhonda Robertson. Finance Chairman Brown made motion to accept the Amended Resolution Adopting Fiscal Year Operating Budget (FY 2024/2025) as presented, seconded by Commissioner Donnell. With no further discussion, the motion passed unanimously. Signature by Finance Chairman Brown.

Ratification of Imposed Civil Penalties

Executive Director, Derek Parnell advised the Commissioners that licensees were in violation of state law. These cases have been investigated and it has been determined the public interest can be served without further administrative proceeding and civil penalties were imposed.

- <u>Case No. 2024-84</u> Authentic Pre-Owned Vehicles, LLC UD.00246140, 2340 Belle Chase Highway, Suite B, Terry Town, LA 70056. In violation of R.S. 32:792(B)(8) Non-Delivery of Title (1 count); R.S. 32:792(B)(12) Issuing temporary tags in violation of law (1 Count); R.S. 32:792(B)(14) Repossessing a vehicle in a timely manner (1Count). Violation penalty \$6500.00. Owner Kendrick Wilkerson came into the LUMVC office for a Compliance Meeting whereas he agreed to make payment in three equal payments of \$2166.66. \$5000.00 to go to consumer for restitution leaving the remaining fine amount of \$1500.00 to the Louisiana Used Motor Vehicle Commission. No attempt at payment has been made and Compliance Investigator Stacy Poche' cannot contact Wilkerson. The LUMVC would like to go against the bond for violation payment and restitution for consumer. A hold will be placed on license which will prevent dealer from renewing until fines are paid.
- <u>Case No. 2024-104</u> Jeffrey Erron Hill dba Jeff's Auto Sales UD.00245048, 4551 Gus Young Avenue, Baton Rouge, LA 70802. In violation of R.S. 32:792(B)(9) Failing to submit monthly sales reports (1 Count) R.S. 32:792(B)(13) Failing to maintain records (3 Counts). Violation penalty \$1400.00. Violation penalty paid in full.
- 3. <u>Case No. 2024-104</u> Conrad's Auto Sales, LLC UD.00243591, 10200 Greenwell Springs Road, Baton Rouge, LA 70814. In violation of R.S. 32:792(B)(8) Non-Delivery of Title (1 Count); R.S. 32:792(B)(9) Failing to submit monthly sales reports (7 Counts); R.S. 32;792(B)(13) Failing to maintain records (1Count). Violation penalty \$2200.00. Owner Darrel Conrad came into LUMVC office for a Compliance meeting whereas he agreed to make payment in three payments, (\$750.00, \$750.00, \$700.00). Mr. Conrad has made first payment at this time.

Executive Director Derek Parnell advised that the total amount of Civil Penalties is \$10,100.00 and further asked that Commissioners ratify the Imposed Civil Penalties and Restitution of \$10,100.00.

- VII. ENFORCEMENT REPORT: Compliance Investigator Supervisor Wisenor advised the Commission of Enforcement Department progress. In June 2024 there were 6 Audits conducted, 1 Notice of Revocation issued, 72 Site Visits conducted, 1 Cease and Desist Order issued, Assisted Title & Registration for Consumer, 5 Violations written, 2 Refunds to Consumer, <u>\$1460.32</u> Refunds to Consumer, 22 Cases Closed/Assigned, 24 Cases Closed/Non-Assigned, 11 Physical Inspections completed. In July 2024 there were 7 Audits Conducted, 1 Notice of Revocation issued, 71 Site Visits conducted, 2 Cease & Desist issued, 24 Assisted Titles & Registration for Consumer, 0 Violations written, 2 Refunds for Consumer, <u>\$31,759.80</u> Refunds to Consumer, 22 Cases Closed/Assigned, 14 Physical Inspections completed.
- VIII. EXECUTIVE DIRECTOR'S REPORT: Executive Director Parnell advised the Commission that staff are getting prepared for renewal period. Meetings were held with the licensing program to ensure licensing program is operating to optimal standard. Upgrades may need to be made. The website will be updated. Once updated state vehicle purchasing contract is updated the LUMVC will move forward with purchasing a new vehicle and surplus older higher mileage vehicle. Announced retirement of Kimberly Baron who has been with LUMVC for 22yrs. She will return on a part-time WAE basis to assist with transition.
