VI. ACT 257

- a. HB 257 introduced by Rep. Gaines in 2018
- b. Cause was lack of prescriptive period of 1009 appeal
1.15 days or 30 days has been suggested
- c. **Charles Davoli**- problem is not guidelines but the process. Lack of prescription shuts system down and creates adversarial environment. Get treated and get back to work.
 - 1. **Sheral Kellar**: WCRI Study of TTD
 - 2. **Julie Cherry**: length adds to opioid addiction
- d. **Michael Morris**- language proposed was the holding point
 - 1. **Sheral Kellar**: stake holder meeting on 2/4 @ 10am and open to the public
- e. **Shannon Lindsey**- There's outliers causing ancillary issues like causation being brought up years later
- f. **Sheral Kellar**- *Arrant* decision says prescriptive period needs to be by statute. *Barber* writ has been applied for.
 - 1. Once final then 2715 issues will be addressed

- a. **Charles Davoli**- looking at consolidating IME
 - 1. Causation & disability is legal conclusion
 - 2. Independent Medical Examination
 - Headquarters doesn't know the districts
 - 3. Provided handout
- b. 1123 Question: Medical condition vs medical diagnosis
 - 1. **Micheal Morris**: think medical was struck
 - 2. **Shannon Lindsey**: "condition" needs to be better defined
- c. Question: "any party" is vague
- d. **Sheral Kellar**- 1314 has a spot added for judge ordered
 - 1. IME attached to 1008?
- e. **Shannon Lindsey**- procedure fix but allows employer to sue employee
 - 1. **Sheral Kellar**: propose compromise
 - 2. **Maria Losavio**: agree with Shannon's concerns
- f. 1124.1
- g. LA. R.S. 23:1317.1- authorize IME statutes
- h. **Sheral Kellar**- add 1 or 2 WC judges to help Davoli's IME taskforce as well as someone from Medical Services
 - 1. **Philip Hunter**: think parties should agree or add strike list
